### RULES & REGULATIONS

#### Commercial space will be separate from Arts & Crafts

1. Applications must be accompanied by a brochure or 4x6 photographs.
2. **Upon acceptance, a non-refundable booth fee is due (do not mail fee until you receive an acceptance letter).**
3. The committee will assign booths, and every effort will be made to vary the type of product by location to maximize sales.
4. Exhibitors advertising discounted merchandise such as "50% off" or "2 for the price of 1" strictly prohibited.
5. Credit card service is available at the Craft Office for a fee of 5% per transaction (American Express, Discover, Master Card and Visa). The minimum charge purchase is \$10.
6. **All booths must be open and staffed during operating hours.**
7. GMF will provide twenty-four hour security, but is not responsible for lost, stolen or damaged items.
8. **Exhibitors must use designated parking areas. Vehicles are strictly prohibited in the craft area during hours of operation.**
9. Overt solicitation and selling items outside your area is not permitted.
10. Exhibitor's attire must adhere to the overall family-oriented theme of the show. Exhibitors and helpers must exhibit professional behavior at all times while on site. The Georgia Mountain Fair reserves the right to determine what constitutes professional behavior and acceptable attire.
11. All booths are required to maintain a fire extinguisher at all times.
12. **Booth alterations are strictly prohibited.**
13. Violation of regulations may be adequate grounds for prompt closure of exhibit.
14. Exhibitors may not sublet or apportion space to anyone else.
15. **Georgia Mountain Fair reserves the right to change or add any rule without notice.**
